

## **Terms and conditions**

Welcome to our website dedicated to Union (the "Website"). You should be of legal drinking age in your country to visit the Website.

These Terms and conditions together with our Privacy and Cookie Policy (the "Terms") govern your use of this Website.

### **Applicability**

These Terms apply to all visits to and all use of this Website of Pivovarna Laško Union d.o.o., located at Pivovarniška ulica 2 , 1000 Ljubljana, Slovenia ("**Pivovarna Laško Union** "), as well as to all information, recommendations and/or services provided you on or through this Website (the "Information").

By using this Website you agree to the applicability of these Terms. We note that these Terms may be changed over time. Such changes shall be effective immediately upon the posting of the modified Terms. Users of the Website are advised to regularly read the Terms for possible changes.

### **Information and Liability**

The Information is for general information purposes only and does not constitute advice. Pivovarna Laško Union shall not be liable for any damages resulting from the use (or inability to make use) of this Website, including any incorrectness or incompleteness of the Information, unless such damage is the result of any wilful misconduct or gross negligence on the part of Pivovarna Laško Union.

These Terms are governed by Slovenian law. Any dispute or claim arising out of or in connection to the use of the Website will be settled by the courts of Ljubljana, Slovenia.

## **Privacy policy**

### **General**

Pivovarna Laško Union d.o.o., located at Pivovarniška ulica 2, 1000 Ljubljana, Slovenia ("Pivovarna Laško Union ") is the controller of the processing of all personal data collected through this website dedicated to our brand Union (the "Website"). Pivovarna Laško Union respects your privacy and complies with applicable privacy laws.

Pivovarna Laško Union only processes personal data that a user voluntarily provides to Pivovarna Laško Union on the Website. This information may include such user's first and last name, e-mail address, date of birth, address and country of residence. Pivovarna Laško Union's purpose in gathering and transferring such personal data will be to provide a user with services available on the Website, for example to participate in a promotional campaign.

### **Transfer, storage and processing of data**

The transfer, storage and processing of data collected through the Website is secured by means of current, usual technical measures. If your personal data has not been used for 12 months, Pivovarna Laško Union will delete your data.

Pivovarna Laško Union may transfer your personal data to its group companies. Pivovarna Laško Union may also provide your personal data to third parties if needed to provide the services available on the Website, which third parties will process your personal data according to instructions of Pivovarna Laško Union and under the responsibility of Pivovarna Laško Union. Pivovarna Laško Union will not provide your personal data to any other third parties, unless there is a legal obligation to do so.

### **Access, correction and removal**

You can request Pivovarna Laško Union to provide access to the personal data it has collected about you at any time. You can also request Pivovarna Laško Union to correct or to delete such personal data.

## **Cookie policy**

The Website will make use of so-called "cookies". Cookies are small text files that the Website stores on your user device.

### **Cookies used on the Website**

The Website only uses the following cookies and for the following purposes:

**Functional cookies:** cookies used to enhance the user friendliness of the Website for visitors. For example, a cookie is placed to remember that you passed the age gate webpage when you are above legal drinking age. Without this cookie, you would have to re-submit this information on every webpage. The functional cookies of the Website that are stored by Pivovarna Laško Union on your computer only remain valid during your session on the Website.

**Analytics cookies:** Pivovarna Laško Union uses Google Analytics cookies, with the purpose to analyse how visitors use the Website. Pivovarna Laško Union can then make improvements to the usability of the Website. Google only processes data obtained via the Website in an anonymous form. Please visit [www.google.com/analytics](http://www.google.com/analytics) for more information on Google Analytics.

**Third party cookies:** the Website allows cookies of social plugins of certain third parties. This enables a user to share content of the Website on social networks. These plugins also enhance the user friendliness of the Website. The (use of the) data collected by these third parties via the social plugins are exclusively determined by such third party as Pivovarna Laško Union cannot read these cookies (nor can these parties read the cookies of Pivovarna Laško Union). For information regarding these third party cookies please check the respective third party's privacy policy.
